1. Three Important Notices for National Health Insurance and Medical System for the Elderly

① National health insurance tax payment collections will begin. Mailing address for tax notice?

Obligation of payment for National health insurance tax comes to the head of household whether you're enrolled in national health insurance or not. Therefore; it will be sent to each head of household. What will be happened if I don't pay?

If the national health insurance tax revenue is deficient, we can't provide enough benefits and will increase medical burdens for national health insurance members. To protect the insurance system for mutual help it is important to pay national health insurance before the due date.

What if it's difficult to pay?

If it's difficult to make a periodic payment, please call for consultation from the tax payment promotion office at (82)4166.

Please make your payment via account transfer.

Take advantage of account transfer payments convenience and never miss a payment by mistake.

All the procedures can be done at the national health insurance pension counter in city. If you desire to choose Yucho bank (postal bank), please go to a postal counter.

②Starting to list a branch number on the insured person's card.

New insurance card color: Vine

New insurance card effective date: Sunday, August 1st

The following 2-digit branch number will be listed on new insurance cards to identify individuals. This branch number will be essential information for verifying your online credentials when using your "my number card" as an insurance card, which is scheduled for use starting from October in 2021.

*When you use your "my number card" as an insurance card, medical institutions can check credentials online by IC chip on the "my number card" or the - digit number on the insurance card. To use your "my number card" as an insurance card, register through "myna-portal".

What is National health insurance?

This insurance has a system that supports the burden of medical expense, insurance holders pay national health insurance tax to receive medical care when sick or injured.

Those who turn 75 years-old will be removed from national health insurance, and enrolled in the medical system for elderly automatically.

Persons who are eligible to enroll:

Those who are under the age of 75 years-old and don't have any other health insurance, need to enroll in national health insurance.

*Self-employed individuals

*Persons who work part-time or as an out sourced employee so and can't enroll in the compnaies health insurance.

*Persons who are retired and don't have work health insurance anymore, or haven't enrolled in any other insurance after they are no longer a independent.

*Farmers

*Foreign nationals, staying in Japan longer than 3 months and haven't enrolled in any health insurance, including national health insurance or through work etc.

.....

- Case procedures are required in the event...
 - *You enroll in social insurance.
 - *You become a dependent on social insurance.
 - ---It is necessary to complete the procedure in order to withdraw from the National Insurance.

If you delay this procedure, you will continue to be taxed for National health insurance. Then in the case you use your national health insurance card to visit your doctor, you must reimburse the National Insurance for 70 or 80% of the fees.

- *You don't have social insurance.
- *You're not a dependent on social insurance anymore and don't have another health insurance.
- ---It is necessary to enroll national health insurance.

If you delay this procedure, high national taxes are levied at once, increasing the burden of payment. Please be careful not to delay in this procedure.

- Reduction certificates will also be renewed. People, who already have their reduction certificate or will be eligible for one after August, will automatically receive a new certificate. If you are planning to apply for it, please apply at the National Pension Division.
- o Insurance fee for medical system for the elderly in 2021 will be informed around the middle of August.
- If you don't receive a new insurance card by August, please contact us. (23)

Please take advantage of direct transfer

Direct transfers can be completed at some financial institution counters or at the tax division in city hall. (If you haven't cancelled your account or changed your account, this direct transfer will be used for next year.) Available financial institute:

- · Shizuoka bank
- Suruga bank

· Shizuoka Chuo bank

- Numazu Shinyo bank
- · Gotemba Nokyo Kyodo Kumiai
- · Shizuoka-ken Rodo Kinko

· Yucho bank

<u>Things to bring:</u> Bank book, Hanko (registered stamp), applicant's Hanko (only if the tax payer's name and bank books registered name are different)

Reminder when you do a direct transfer:

- *Direct transfer deductions start the next month, or 2 months after you apply.
- *You will need to have your registered stamp as a form of ID, so please try to apply for it at one of the for mentioned financial counters.
- Free tax consultation from a tax accountant

Date: Every 10th of the month (from April to January in 2022), starting 1:00p.m. to 4:00 p.m.

In the case of weekends or holidays consultations will be the next day of business day.

Place: City Hall, main building 1st floor

Contents: General tax consultation such as Income tax, inheritance tax and gift tax etc.

How to apply: Come to the office directly or contact the tax department management/ proof division staff.

*Consultation will be conducted in the order of reception.

Extended reception hours

Every 2nd and 4th Tuesday of the month (excepting holidays) will be extended business hours for issuance of tax certificates or tax payment consultation until 6:45 p.m.

• To the those who need proof of tax payment

When you pay your taxes by a direct transfer, you might not receive your tax payment certification on that day. When you pay your taxes at the window, such as financial institutions and convenience stores, please keep a receipt, because it may take around 10 days for a confirmation of payment.

^{**}Take advantage of the safety and convenience of direct payment.

3. Separate Your Recyclable Properly

In general recyclables are meant to be glass or plastic bottles, cans, papers, metal, or small appliances. Depending on each recyclable there are different collection dates or dedicated containers provided, so please make sure to recycle these items correctly.

Container's color:

Cans are blue, bottles are green, small appliance are orange, metal is brown, hazardous spray cans are cream colored, plastic bottles are provided a blue net.

... Please do not put cans into metal container by mistake.

4. How to Dispose Hazardous Garbage the Proper Way

These days, there are many hazardous items found in non-burnable garbage bags. Here is some special hazardous garbage items you need to know how to dispose.

- Pesticides
 - Pesticides disposal is complicated so please be advised by the manufacturer, sales store, or the store purchased from and dispose properly.
- ② Cassette cylinders
 - Please ensure these are completely empty and do not make a hole to take it out on hazardous garbage day. (Container color is cream)
- 3 Lithium-ion batteries
 - These batteries can possibly start a fire when crushed. When you dispose it, please seek guidance from cooperating stores for small rechargeable batteries.
- 4 Bullet casings
 - If you find hazardous items such as an old bullet casing while deep cleaning your house, do not dispose these as non-burnable at collection points. Make sure to report them with the Gotemba police department (Tel: 84-0110) immediately.

To dispose Styrofoam from your house, use the Styrofoam collection box. Each location is described in the waste reduction guidebook. If you cannot use or find a Styrofoam collection box, please dispose as burnable garbage at your garbage collection spot.
